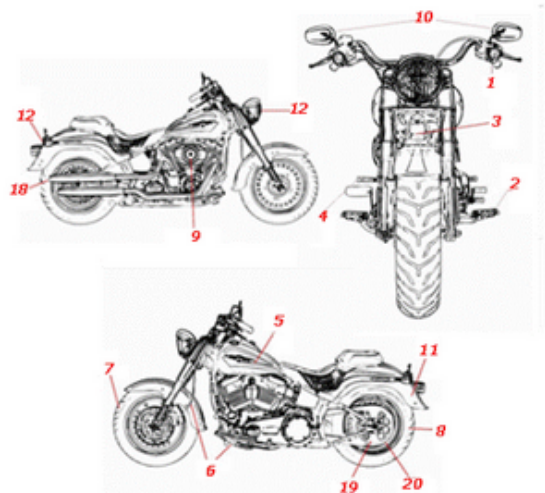

RENTAL TERMS & CONDITIONS

1. General

Renting a bike is only possible if the contract is correctly completed and if the following conditions are met. The Lessee confirms by signature that the data entered is accurate and accepts all the conditions of this contract. The Lessee has no right to rent the vehicle. The lease can be withheld without specific reason.

The lessee shall use the leased vehicle with care, in accordance with the requirements of traffic and with caution. Off-road driving as well as racing is prohibited. Expenses for consequential damages in breach of the above are the sole responsibility of the lessee. Assemble or disassemble parts or accessories on a rental motorcycle is strictly prohibited. The lessee agrees to personally ride the rented motorcycle and not use it for profit. A sublease is prohibited and liable to a heavy fine.

2. Rental

- ✓ **Minimum age:** 20 years old and 2 years of license. Exceptions are sometimes granted.
- ✓ **Unlimited mileage:** included in all our rates.
- ✓ **Gas:** motorcycles are delivered with a full tank and must be returned with a full tank.
- ✓ **Insurance and assistance included:** comprehensive insurance and repatriation included.
- ✓ **Franchise:** CHF 2000.00 taken as a security deposit in cash or by a reservation on the credit card.
- ✓ **DOWNPAYMENT OF 30% OF THE RENTAL CHARGES IS DUE AT RESERVATION.**
- ✓ **Payment:** Rental and deposit are paid in full at the beginning of the rental period.

3. Operating Hours

- ✓ **Day:** one day is 24 hours long.
- ✓ **Weekend:** Friday 18:00 to Monday 10:00.
- ✓ **Week:** seven days in a row.
- ✓ **Saturday:** 9:30 to 16:30.
- ✓ **Pick up and drop off:** at *Harley-Davidson Geneva – Route des Jeunes 4A – 1227 Acacias*

4. Fines

- ✓ **CHF 25.00** per hour delay on the return.
- ✓ **CHF 2.80/liter** for non-filled tank.
- ✓ **CHF 200.00** for any damage not reported upon return. Dated photos in support.

5. Charges

Our prices are firm and final, they include insurance, assistance and unlimited mileage.

6. Cancellation

For cancellations within less than 24 hours' notice before the start of the tenancy, the entire deposit will be retained. In case of bad weather, rental date can be moved to availability.

7. Collection

Pick up and drop off of the bike at our store only. The bikes are delivered from 10:00 on the first day of the rental and returned not later than 18:30 on the last day, except Saturday, which will be not later than 17:00.

For weekend rentals, motorcycles are delivered on Friday evening at 18:00 and are returned on Monday morning at 10:00.

Drop off before term, out of opening hours is possible but does not qualify for a discount.

8. Accidents, theft or other damage

Abroad, as in Switzerland, any repairs must be performed only by a Harley-Davidson official agent. The Lessee shall pay all costs incurred if the clause is not respected. All incidents must be reported immediately to the rental company.

In an accident, an official report is to be issued by the police. The lessee remains responsible for damage to the rental company. The cost of rehabilitation is estimated at the return of the vehicle. The driver is responsible for paying these charges.
